How the solution works

Instant Unlock uses a widget or a web-page redirect that temporarily unlocks a credit profile so that a consumer can complete an application on the fly. Without Instant Unlock, the consumer must log into their Experian account to unlock their file and then log in again to relock it, adding friction and frustration.

Requirements to enable an Experian Instant Unlock widget in the existing online application process:

- A JavaScript file for integration
- A CSS file to style the external messaging

Experian will provide all instructions and resources to integrate the changes.


Consumers can unlock their credit report with a simple three-step process

- 1. OPT-IN to the process
- 2.AUTHENTICATE identity
- 3. AUTHORIZE removal of the restriction
