



Cleaning and hygiene

- Heightened cleaning measures: Experian will work with venue partners to ensure a deep clean of the venue is taken before the event begins. In addition, we'll work with the venue to assure the highest standards of cleanliness and hygiene are maintained throughout the course of the event, specifically in all high-touch areas, such as door handles, restrooms, food and beverage areas, and conference rooms between sessions
- Personal hygiene: Hand sanitizing stations located throughout the event space along with clear signage indicating sanitizing stations and restrooms for hand washing will be provided onsite.

Physical distancing

- Safe registration parameters: Vision 2022 will provide a COVID-19-safe registration desk that will provide socially distanced safety measures, sanitation areas and spaced-out registration staff.
- Food and beverage stations: Experian will work with venue partners to provide the highest standard of food safety at Vision 2022.
- Physical contact: Attendees at Vision 2022 will be encouraged to avoid physical contact, such as handshakes, embraces and exchanging of business cards, among others.
- Physical distancing: Vision 2022 will function in accordance with official CDC, national and local guidelines in addition to any venue- or location-specific regulations required within the boundaries of our event venue at the time of the event regarding social distancing. However, Experian will work with venue partners to provide as much physical distance as possible during sessions, meals, networking events and throughout the event space. Attendees are encouraged to make a conscious effort to keep their distance as recommended by government guidelines.





Protect and detect

- Personal protective equipment (PPE): Vision 2022
 functions in accordance with official CDC, national and
 local guidelines in addition to any venue- or locationspecific regulations required within the boundaries of
 our event venue at the time of the event regarding PPE.
 This may include mandatory face masks. If not required
 at the time of the event, masks are always optional.
- Health screening: Vision 2022 will follow relevant health authority guidance on screening participants. This may include checking the temperatures of everyone on entry, thermal scanning, or other screening processes. Participants will be asked to refrain from attending Vision 2022 if they're feeling unwell and have any COVID-19-related symptoms. Teams will follow local health authority guidance on detecting and managing anyone who displays symptoms of COVID-19. Experian will make attendees aware of the closest hospitals, pharmacies, and urgent care facilities to the event venue to use at their discretion.
- Trace and contact: Should it be necessary, we'll work
 with local authorities to trace and contact participants at
 our events, subject to local privacy regulations.

Communication

- Pre-event messaging: We'll provide clear and consistent pre-show communication to ensure proper expectations are in place for attendees. Pre-event messaging can include health organization updates, admission policies, hygiene briefings and health protection measures.
 Specific details will also be included on the event app.
- Minimal printed materials: Vision 2022 will have minimal printed materials onsite to reduce the amount of physical contact and spreading of germs.
- Onsite communication: Attendees will be reminded throughout the event through our event app, signage, and other forms of communication of the safety measures being taken onsite in accordance with official CDC, national and local guidelines in addition to any venue - or location-specific regulations required within the boundaries of our event venue.
