Hospital Price Transparency timeline

January 1, 2024

- .txt file in website footer
- Price Transparency Final Rule web link
- Good faith effort
- Increase in assessment activity

July 1, 2024

- CMS 'machine-readable file (MRF) template must be .JSON or .CSV
- Include all required data fields in template
- Include attestation in MRF

January 1, 2025

The following will be required in MRFs:

- Estimated allowed amount
- Modifier
- Drug unit of measurement
- Drug type of measurement

February 25, 2025

Executive order signed by US President, effective May 27, 2025

May 27, 2025

Federal Departments of Health and Human Services, Labor and Treasury to improve enforcement and compliance of Price Transparency Rule through updated guidance or proposed rules.
